

## **REGULATIONS & INSTRUCTIONS**

Please be aware of the regulations and read bevor starting fishing carefully Fishing limit per day:

- In total 7 game fish (salmonids), including 3 white fish ("maränen/ renken") (corigonids). 1 Salmon trout per day.
- 1 piece of carps exclusively between 30 and 60 cm during the
- months and from the 1st July to the 30th November.
- 2 Fishing rods may be used per ticket for angling, one hygene is allowed per rod with a maximum of 5 nymphs.
- Every caught fish, which has the proper allowed length and which corresponds with the requirements on the ticket, as well as fishes without angling restrictions, must all be entered immediately on the fishing register card with a pencil.
- Fishing register cards for one day-, 3 day-, week-, 14 day-, and month tickets are under obligation to be handed in at the issuing office or at the Castle Fishery after angling. Year ticket holders are obligated to hand in their fishing registers by 31st December at the Castle Fishery.
- Failure to return the fishing register is liable to a money penalty of EUR 100,00 with, as a further consequence, no renewal of the angling ticket!

### **GENERAL PROHIBITIONS**

- Nymph angling from 1st October.
- The fishing rod left unattended.
- The usage of echo sounders during fishing.
- The implementation of live bait.
- The implementation of dead bait from other waters.
- Catching with nets, fish traps and barbed hooks.
- Angling on the lakeside from the Castle Fishery up to the outlet of the Fuschl Ache stream.
- Angling within a radius of 50m of stream mouths. The Fuschl Ache stream is prohibited.
- The usage of "Setzkeschern"
- Removing of pikes to the lake.
- Either from the shore or from a boat, the length of angling activity is restricted to 40m.
- Only in the accompaniment of a person with parental authority (adult) is it permitted for youth under the age of 12 to use one of the two allowed rods in the context of the chosen catch permission.
- Youth over the age of 12 must obtain his/her own angling permit.



# **INSTRUCTIONS & PROHIBITIONS**

- Huntsmanly behaviour, together with the pursuit and upholding of the rules are expected of
  every angler! The fish permit booklet must be presented to the controlling authority on
  request for endorsement.
- Requests to open the angling trunk, as well as diverse pockets etc. must be executed promptly without delay!
- Abuse and offences against the current rules and regulations, or the damaging of the nets, will not only result in the withdrawal of the permits, but could also be reported to the police!

## **FISH SIZES & SEASON**

It is not permitted to use live baitfish and setfish! Every fisherman has to carry a cooling bag with cold packs in order to be able to properly supply caught fish.
